### Work/Asset Projects

The following projects have recently been **completed** by the Shire of Gingin:

- Re-roof of Granville Civic Centre
- Installation of Beach Emergency Number signs

The following projects are **currently in progress** around the Shire of Gingin:

- Upgrade of Granville Park Ablution Block – some items have been completed with re-roof and painting works. Works remaining are re-tiling of floor areas, minor plumbing replacements, external wall stone cladding. Works expected to be undertaken over 4-6 weeks.
- Design of the renewed Gingin Weir structure
- Construction of Gingin Outdoor Activity Space
- Gingin Football Lighting Tower Partial Renewal (2 x Lights)

The following projects are **due to commence** shortly in the Shire of Gingin:

- Installation of new town entry statements for the Gingin town site
- Upgrade of the Guilderton Foreshore Ablution Block
- Installation of two replacement water monitoring bores within the Lancelin Sporting Complex by the Department of Water & Environmental Regulation commencing the week of 1 March. This process is expected to take approximately 8 weeks

### Roadworks

The following roadworks have recently been **completed** by the Shire of Gingin:

- Maintenance grading on Wannamal Road South, Wannamal Road West, Red Gully Road, Pin Pin Road and Beermullah Road West

The following projects are **currently in progress** around the Shire of Gingin:

- Reconstruction of Cowalla Rd for 2.5km from Mimegarra Road heading towards Cowalla Bridge has been completed. Sealing works have been completed. Now awaiting linemarking
- Reconstruction of Mortimer St, Guilderton - awaiting sealing

The following roadworks are **due to commence** shortly in the Shire of Gingin:

- Resealing works on Bootoo St (Lancelin), Edwards St (Seabird), Mullins Way (Guilderton) and Weld St (Gingin). Awaiting sealing contractor
- Dingo Rd gravel resheet
- Kendall St asphalt overlay
- Maintenance grading of Bennies Rd, Beermullah Rd West, Mimegarra Rd, Nilgen Rd and all other gravel roads across the Shire

### Difference between Fire Bans

We've all heard that there are different types of fire bans but do you know the difference?

There are 2 x types of bans you will hear about most commonly in the Shire of Gingin which are:

- **Total Fire Ban**
- **Harvest, Hot Works & Vehicle Movement Ban**

**Total Fire Bans** are set by the **Department of Fire & Emergency Services**. Generally they will set this ban the day before it is due to commence and it will usually be put in place from midnight that night until midnight the following night.

**Harvest, Hot Works & Vehicle Movement Bans** are set by the **Shire of Gingin**. The Shire will impose this type of ban when the predicted weather conditions (as classified by the Bureau of Meteorology) are rated 'Very High', 'Severe', 'Extreme' or 'Catastrophic'.

#### BOTH BANS:

- Prohibit open fires for the purpose of cooking, camping or outdoor entertainment including fire pits and bonfires.
- Prohibit the undertaking of hot work such as metal work, grinding, welding and gas cutting in the open air except for business and industry if regulatory conditions are met.
- Prohibit the undertaking of off-road activity using a four-wheel drive, quad bike, motorcycle, bobcat or similar vehicle, except for agricultural purposes or by business and industry if regulatory conditions are met.
- Can be placed at any time of year.

The main difference between the 2 types of bans is that the Harvest, Hot Works & Vehicle Movement Ban also prohibits the use of harvest vehicles for harvesting operations which is not prohibited if there is only a Total Fire Ban in place.

It is **YOUR RESPONSIBILITY** to find out if there is a ban of either kind in place.
