

# Lancelin Foreshore Redevelopment Set to Go Ahead

The redevelopment of the Lancelin Foreshore has been a long time coming. However, Council has now taken delivery of the proposed draft plans for this exciting project which will include:


- Major upgrades to the existing car parking adjacent to Grace Darling Park and along Cunliffe St
- A new adjoining boardwalk and gazebo
- Disability access to gazeebo
- Provision of increased lawn area
- · Revegetation in the vicinity of Hopkins St
- · New footpaths throughout the area
- Sand renourishment
- Improved Hopkins St road surface and drainage

These plans are essentially the same as previous designs created after public consultation in previous years. The design has undergone several revisions during the past 4 years (given coastal erosion concerns) but with Council's decision last year to retain public access to Edward Island Point, the draft designs consequently reflect what was originally requested through public consultation.

Following the closure of the feedback period, the draft plans will be presented to Council at a Council Meeting for formal adoption and then tenders will be invited for the construction of the Lancelin Foreshore Redevelopment.

### **Restricted Burning Period**

The Restricted Burning Period is due to commence from 1 March 2021 subject to conditions being appropriate.

Residents of the Shire of Gingin district wishing to undertake any burning between 1 March and 31 May are reminded that you will need to apply for a permit from your local Fire Control Officer (FCO) to burn any grass, paddocks, bush, etc. Refer to your Fire Break Orders (www.gingin.wa.gov.au/services/emergency-services/ firebreak-orders.aspx) for a list of local FCOs.

#### **REMEMBER - YOUR FIRE: YOUR RESPONSIBILITY**

If you have misplaced your copy of your Fire Break Orders (posted to all rate payers last August) then copies are available for downloading from the Shire of Gingin's website - www.gingin.wa.gov.au/services/ emergency-services/firebreak-orders.aspx.

**REMEMBER** - you must comply with the conditions set out on your Fire Permit. You are asked to comply with these conditions for a number of reasons including the safety of yourself and your neighbours.
