Message from the

Shire President

Welcome to the Shire of Gingin's Budget Bulletin for 2024-25.

For the 2024-25 financial year the Shire's annual budget has been set at **\$41.02 million** which is the largest annual Shire budget set to date. It includes a Capital Works Program of \$12.56 million, a substantial Annual Roads Program of \$7.73 million, and a Plant Replacement Program of \$2.37 million.

With a 6% rates increase this financial year, rates revenue is expected to be \$11.07 million, with the balance generated from State and Federal grants, as well as fees and charges. This year's budget was another tight one to balance as we continue to battle rising costs of doing business along with the considerable infrastructure needs of our rural and coastal communities, particularly those pertaining to roads, built environment, and ageing and unavailable plant.

Big ticket **capital works projects** this year include continuing major upgrades for Guilderton Caravan Park, Lancelin Sporting Complex bowling green upgrade, and major works to the Lancelin Independent Living Units.

Major **road projects** prioritised this budget include Cullalla Road, Wannamal Road West, Orange Springs Road, and Sadler Road.

Among the Shire's **plant for replacement** are two prime movers, a water tanker, bush fire brigade fire tanker, and light tanker. A detailed list of all projects can be found on the next page.

We are also progressing **waste management reform** for the Shire to bring us in line with WA Government's Waste Avoidance and Resource Recovery Strategy 2030.

I'd like to take this opportunity to thank everyone in the community who has supported Council and the Administration through another challenging year. I'm also very grateful for the dedication of the Staff who, at times, have to work in some difficult situations and do a great job in the process. Finally, I'd like to thank my fellow elected members for their continued support and commitment to our communities.

Tip Pass Update!

You may be wondering why there isn't a new tip pass in your Rates envelope this year - this is because we are changing over to a new system!

In the coming months, the Shire will be rolling out an information campaign about how we are improving our Waste Management processes. This will include providing all ratepayers with a **new plastic Waste Facility Pass card** which is issued once so it can be reused every year, instead of the old card pass which had to be replaced every year.

Rates & Charges

Division 6, Local Government Act 1995

At the Shire of Gingin's Special Council Meeting on 13 August 2024 to adopt the Budget for 2024-25, it was resolved that the rates and charges specified hereunder be imposed on all rateable properties within the District of the Shire of Gingin in accordance with the provisions of the *Local Government Act 1995* and the *Waste Avoidance Resource Recovery Act 2007*.

Rates

General Rate – Gross Rental Values (GRV) – 9.8154 cents in the dollar on all Gross Rental Valued rateable land within the district.

Differential General Rate – Unimproved Values (UV) – 0.4742 cents in the dollar on all Unimproved Valued rateable land (excluding Rural Intensive and Mining) within the district.

Differential UV Intensive Rate – Unimproved Values (UV) – 0.6999 cents in the dollar on all Rural Intensive and Mining Unimproved Valued rateable land within the district.

Minimum Payment

The minimum payments of \$1,323 for GRV rated properties, \$1,531 for UV rated properties (excluding Rural Intensive and Mining), and \$2,609 for Rural Intensive and Mining rated properties have been determined by Council on the basis that all ratepayers must make a reasonable rates contribution to enable the Shire to deliver essential services.

Rubbish Charges

All Urban and Rural Residential properties with a residence are charged \$256 per annum per service of one 240 litre capacity mobile rubbish bin.

Collection of a second or subsequent rubbish bin/s for all properties is charged at \$256 per bin per annum excluding your recycling bin which is supplied free of charge.

Rating Objects and Reasons

The rates in the dollar (\$) for the various rates are calculated to provide the shortfall in revenue required to make up the budget deficiency to enable the Shire to provide the level and range of works and services required in the 2024-25 financial year after taking into account all non-rate sources of revenue.

Purpose: UV - Rural and Rural Other (including exploration and prospecting tenements)

The objective of this differential rate category is to impose a differential general rate on land held or used for the purposes of rural broad acre farming, rural residential, rural industry, and other non-intensive uses.

Purpose: UV - Rural Intensive/Mining

The objective of this differential rate category is to impose a differential general rate on land held or used for the purposes of the following land uses defined within the Shire of Gingin Local Planning Scheme: Agriculture Intensive, Animal Husbandry – Intensive, Aquaculture, Industry – Extractive, Industry – Mining.

UV - Rural and Rural Other

The reason for this rate is to reflect the lower impact on transport infrastructure and monitoring of land use/environmental impacts compared to the Rural Intensive/Mining – UV category. It also ensures that all ratepayers make a reasonable contribution towards the ongoing maintenance and service provision of works, services, and facilities throughout the Shire.

Non-urban properties on Avon Waste's existing service route on application are charged \$256 per annum per service of one 240 litre capacity mobile rubbish bin and \$256 for the second or subsequent bin/s excluding a recycling bin which is supplied free of charge.

Industrial and commercial properties that are not vacant are charged \$300 per annum per service for one 240 litre capacity mobile rubbish bin. Collection of a second or subsequent bin/s for industrial/commerical properties is charged at \$300 per bin per annum.

Waste Management Levy

A waste managmenent levy of \$188 is charged on all GRV properties and UV properties. Properties used for commercial purposes are levied at \$260.

This levy contributes to funding current and future waste infrastructure and initiatives, and entitles each of these properties to their own waste facility pass with specified access capacities.

What is the ESL?

The Emergency Services Levy (ESL) is a portion of your rate payment that is forwarded to DFES to fund the Career Fire and Volunteer Fire and Rescue Service, Bush Fire Brigades, and SES units throughout WA.

Late Payment Penalty - Rates, ESL, Waste Management Levy & Rubbish Charges

A charge of 7% per annum calculated daily by simple interest will apply as follows:

- No instalment option taken interest shall begin to accrue on Rates and/or ESL and Rubbish Charges that remain unpaid at 11 October 2024. Eligible pensioners are exempt.
- Instalment option taken interest shall begin to accrue daily on any rates instalment payment that remains unpaid after the due date of the instalment, and will continue to accrue until such time as the instalment is paid. Eligible pensioners are exempt.

Minimum payment in respect to UV - Rural and Other

The object of the proposed minimum payment of \$1,531 is to ensure that the proportion of total rate revenue derived from Rural and Rural Other UV properties is consistent with the overall rate increase for this category. This rate is considered to be the base minimum rate by which all other UV rated properties are assessed. It also recognises that every property receives some minimum level of benefit of works and services provided.

Rural Intensive/Mining – UV

The reason for this differential rate is to reflect the higher impact on transport infrastructure and monitoring of land use/environmental impacts compared to Rural and Other – UV properties, and the capacity to pass on the rates charge as a business cost. It also ensures that all ratepayers make a reasonable contribution towards the

 Interest on Rates and/or ESL, Waste Management Levy, and Rubbish Charge arrears will continue to accrue each day until arrears are paid.

Instalment Plan Interest Rate

A charge of 5.5% per annum calculated daily by simple interest will apply from 1 July 2024. Eligible pensioners are exempt.

Due Dates for Payment of Rates, ESL, Waste Management Levy & Rubbish Charges No instalment option: 11 October 2024

Two instalments option:

- 11 October 2024
- 14 February 2025

Four instalments option:

- 11 October 2024
- 13 December 2024
- 14 February 2025
- 22 April 2025

Alternative Arrangements for Payment of Rates

Upon application the Shire may accept payment by way other than one, two or four instalments (subject to agreement in writing by both parties). A single administration fee of \$15 will apply for this type of payment. Eligible pensioners are exempt from this charge.

Paying Your Rates

Rates can be paid in person at the Gingin or Lancelin Shire Offices by cash, cheque or EFTPOS (excluding American Express and Diners cards).

The Shire also offers the convenience of 24 hour, 7 days a week payment by BPOINT (credit card) on 1300 276 468 or via gingin.wa.gov.au/make-a-payment or by BPay for cheque and savings accounts.

Proposed Rate in \$: 0.006999

Minimum payment in respect to Rural Intensive/Mining - UV

The object of this minimum payment is to reflect the additional costs from this sector associated with the higher impact on transport infrastructure and environmental monitoring.

The minimum rate of \$2,609 also ensures that the proportion of total rate revenue derived from Rural Intensive/Mining UV properties is essentially consistent with the overall rate increase for this category and recognises that every property receives some minimum level of benefit of works and services provided.

A summary of the differential rates to be used for the 2024-25 rating period are as follows:

Differential Rating Category	UV Rate in \$	Minimum Rate	Income
Rural & Other - UV	\$0.004742	\$1,531	\$2,710,814
Rural Intensive - UV	\$0.006999	\$2,609	\$1,070,237

In arriving at the differential rates in the dollar, Council has attempted to balance the need for revenue to fund essential services and facilities with the desire to limit any increase on the ratepayer to affordable levels.

The differential general rate and minimum payment differs from that set out in the local public notice to accommodate additional reserve funding for future work.

Green Waste Kerbside Collection

OCTOBER 2024

Each year the Shire of Gingin undertakes a green waste kerbside collection service for Residential and Rural Residential properties. Residents wishing to take advantage of this service will need to have green waste placed on the verge by no later than **Monday 7 October 2024**.

Conditions for collection:

- Where possible, keep all green waste clear of reticulation, footpaths, street signs, poles, and fences.
- Piles for collection must be no larger than 5m³. Contaminated green waste and piles greater than 5m³ will not be collected. A notice will be
 left by the contractor detailing the reason why your green waste was not collected.
- If residents require the contractor to return to collect their waste, then charges will apply.
- Residents who miss the collection period will have to dispose of their green waste at their own cost.
- Collected green waste will be chipped, conditioned, and offered free of charge to Shire of Gingin residents. Keep an eye on the Shire's website, Facebook page, and Country and Coast newsletter for details of where and when mulch will be available for collection.

NO lawn clippings, sand, wire, steel posts or rocks.
NO spiky vegetation eg, bougainvilleas, cacti, or date palm fronds.
NO plant root balls, succulents, stumps, or other chunky plant material.
NO large tree trunks with limbs greater than 150mm in diameter.

Please ensure:

- Green waste is uncontaminated. Contaminated material can cause breakage to contractor machinery or serious injury to the operator.
- Tree branches/limbs are less than 150mm in diameter.
- Prunings are laid out with the ends facing the street.




Want to Stay Informed? How we're able to communicate with you...




We're a big Shire with lots of different communities and demographics - we have younger generations who prefer digital technology and social media to get their news, right through to senior community members who prefer to read printed material.

Emergency Services Levy for a Safer State

The Emergency Services Levy (ESL) helps deliver essential fire and emergency services across Western Australia.

No matter where you live in our vast State, you will see the ESL hard at work.

The ESL helps protect 2.9 million Western Australians by funding the Department of Fire and Emergency Services (DFES) and its volunteers to respond to bushfires, storms, cyclones, floods, road crashes, hazardous spills and search-andrescue missions. It supports around 26,000 fire and rescue, marine and emergency services volunteers and more than 1,800 career firefighters, operational and corporate staff from DFES to provide around-the-clock fire and emergency services.

Your ESL contribution also helps fund fire and emergency vehicles, aerial fleets, life-saving equipment and emergency services facilities.
