#### **PURPOSE**

To consider accepting the tender submission from Western Stabilisers at a price of \$7,347,953 to undertake construction works for the Orange Springs Road Upgrade (RFT 05/2019).

#### **BACKGROUND**

RFT 05/2019 Construction of Orange Springs Road Upgrade was advertised in the *West Australian* on 2 November 2019 in accordance with s. 3.57 of the *Local Government Act* 1995.

The submission period closed at 4pm on 25 November 2019, with six tender submissions being received from the following companies (listed in no particular order):

- Lendlease;
- WCP Civil;
- Western Stabilisers:
- Robbro Road Construction Pty Ltd;
- Tempo Construction & Maintenance Pty Ltd; and
- Menzies Quarries.

A mandatory site meeting was held on-site (Orange Springs Road) on Friday 8 November 2019. All submitting tenderers were represented at that meeting.

Delegation 2.9 empowers the Chief Executive Officer to accept or reject tenders with a value not exceeding \$250,000. Given that the tenders received all exceed this value limit, RFT 05/2019 cannot be dealt with under delegated authority and as such is therefore presented to Council for consideration.

The tender received from Menzies Quarries was deemed to be non-conforming as it did not contain the Qualitative Criteria (with the exception of Key Personnel and Tenderer's Offer) necessary for assessment and therefore it was not included in the assessment process.

All tenders were assessed independently by the three member Tender Evaluation Panel (consisting of the Executive Manager Operations, Coordinator Operations and Coordinator Assets/Projects). A weighted scoring method was used with the following weightings:

•	Price	40%
•	Relevant Experience	15%
•	Key Personnel Skills & Experience	20%
•	Tenderer's Resources	10%
•	Demonstrated Understanding	15%

The price score was calculated using an average based scoring method as approved through the Western Australian Local Government Association's (WALGA) Procurement division. Each panel member scored the tenders separately. All other qualitative criteria from each tenderer was assessed against a rating scale, with 0 points as an inadequate offer with many deficiencies and 10 points as an outstanding offer which greatly exceeds criterion.

The individual tender evaluation assessments and the Summary have been distributed to Councillors under separate confidential cover as **Appendix 1**. The reason for confidentiality is that the tenders must be dealt with as commercial in confidence due to the financial nature of the tenders.

Once the individual assessments were completed, the qualitative scores were averaged and summarised. The summarised scores (out of 100) are:

WCP Civil	45.17
Robbro Road Construction Pty Ltd	44.65

Robbro Road Construction Pty Ltd is the only tenderer that resides within the Shire of Gingin. However the Shire does not have a regional price preference policy so this consideration could not be applied to the tender process.

Porter Consulting Engineers were engaged to complete the detailed design and assist in the completion of the tender documentation. Structerre Consulting Engineers provided the geotechnical survey and reporting to determine the existing depth and structure of the existing pavement. Stabilisation Technology were engaged to undertake a pavement design for the entire length of Orange Springs Road based on the geotechnical survey results.

The length of Orange Springs Road is 17.86km, with works proposed to start at the western (Cowalla Road) end because this has been determined (based on the geotechnical results) as the weakest section of pavement. The detailed design for Orange Springs Road has been subjected to several reviews and amendments to try and reduce the native vegetation clearing impact, which has increased the cost per kilometre to deliver the project.

The reasoning behind reducing the clearing footprint is to try and expedite the clearing application process. The total area to be cleared is just over two hectares for the entire 17.86km length of road.

A clearing permit has been granted by the State Government's Department of Water and Environmental Regulation (DWER), however as of 27 November 2019 an appeal has been lodged which must be determined by the Appeals Convener. The time taken for the appeal to be assessed has not been advised. Shire Officers have been advised by DWER that the appeal can only be appealed based on the process that DWER used to assess the clearing application, and Shire Officers are hopeful that the appeal will be resolved quickly.

The clearing application has been referred to the Department of Environment (Federal Government) as the area proposed for clearing falls within a Threatened Ecological Community (TEC), Banksia Woodland, with the clearing proposed to be significant. The public consultation period closed approximately two weeks ago, and the Shire is following up on an outcome. The pavement reconstruction works cannot be commenced in earnest until such time as both State and Federal Government clearing applications are granted.

In 2017/18 the State Government granted \$5.2m to the Shire of Gingin in untied grant funding based on the Draft Agricultural Lime Strategy to be spent in two years, 2018/19 to 2019/20. As the Shire was waiting on the assessment of the clearing of native vegetation and detailed design it was determined that the works would be delivered in the final year of the project, 2019/20. The Shire currently has \$4,257,832 of contract costs budgeted for the project. The contract cost associated for the Shire to deliver their portion of the works (traffic control, gravel cartage, bitumen works, site office hire, generator fuel, etc) is approximately \$72,300 (excluding GST) per kilometre.

#### **COMMENT**

The tenders supplied were generally of a good standard with sufficient information to make an informed assessment. The individual evaluators' comments are provided in **Appendix 1**.

The RFT called for tenderers to provide a cost to undertake the excavation and installation of works to a cement stabilised (limestone) sub-base levels as per the design. This included delivering the gravel base course to selected stockpile sites along Orange Springs Road so that the Shire can cart and install the gravel base course, then seal. The base course lay down areas are incorporated into the centre of the road train turn-arounds to reduce operating costs.

There is a large variance in price between the lowest and the highest priced tender. The lowest priced tenderer submitted information in their tender from an independent auditor's report which flagged that there were concerns with regards to the continuing viability of the business. This raised questions with the Tender Evaluation Panel as to the company's ability to deliver the project, and as such it was deemed to be of a high risk to the project.

After undertaking the individual assessments and averaging the evaluator's scores the preferred tenderer is Western Stabilisers utilising the weighted point scoring system. Each tenderer was scored on their methodology to complete the works, with each tenderer providing varying methodologies to complete the works.

At the mandatory site meeting all prospective tenderers were advised that, although the tender was to provide works for the entire length of Orange Springs Road, the Shire was working to a budget. It was unlikely that the tenders received would fall within the budget, and as such the scope (length) of the works would be negotiated with the preferred tenderer based on their tender submission.

The tender received from the preferred tenderer, Western Stabilisers, of \$7,347,953 for the entire length of the road equates to \$483,720 per kilometre (excluding GST). This rate would still need to be negotiated with the preferred tenderer, but considering the tenderer and Shire contract cost rates it is anticipated that the total works to be delivered could be in the vicinity of 8 to 12 kilometres, subject to negotiation.

Western Stabilisers provided a methodology to complete the works that the Shire had not anticipated and as such the Shire sought clarification to ensure that the works would met the tender detailed design and specifications, and that no unfair advantage could be implied. The Evaluators are of the view that the proposed methodology is capable of delivering the works as per the specification and to the standard detailed in the RFT and associated documentation, whilst maximising the length of Orange Springs Road able to be reconstructed.
